I hope that you have all had the opportunity over Christmas/school holidays to spend some time relaxing with whanau and friends and 'recharging your batteries' to take on the challenges of what could be a pivotal year for Te Runanga o Te Rarawa to:

- determine whether we reach a point of settlement (or not) with our Treaty claims negotiations, and
- finally and formally adopt our new constitution and restructure our Runanga for the new millennium
- exercise our right to determine who will represent us in Parliament for the next 3 years. Make sure you and your eligible whanau are registered on an electoral roll (preferably Maori!) and that you all vote!

These three issues are huge in terms of the impact they will have on our future aspirations as a Runanga to work more effectively with our whanau and hapu to empower and assist their development aspirations.

Te Runanga o Te Rarawa will continue the essential mahi as the interface with central and local government, - monitoring policy development and implementation, maintaining relationships and, where appropriate, developing MOUs (Memoranda of Understanding) that protect and enhance the interests of Te Rarawa. So what is going to happen next month? Feb 10th (Tuesday) 10am - Ngatimanawa marae, in Panguru. A special Runanga hui focusing on an update by the Negotiation Team of the Treaty Claims direct negotiations

Nga mihi nui ki a koutou ma, nga whanau with the Office of Treaty Settlements. Feb 23rd (Wednesday) 9am - Morehu Marae, Pawarenga will host the 1st Runanga huia-marama of 2005. Please take note of the change of date from our usual 3rd Wednesday of the month to the 4th Wednesday.

> One of the highlights of this hui will be the acknowledgement of matua Ossie Peri and the well-deserved recognition he received in the New Year Honours List in being made a Member of the NZ Order of Merit (MNZM). E te rangatira he mihi nui ki a koe.

> He mihi nui hoki ki a Vance Winiata who has taken on a new job as General Manager of the Maniapoto Maori Trust Board. Vance has contributed to Te Rarawa in a positive commercial way and has left a legacy of a housing project which will continue under the able management of the housing team led by Turi Te Hira.

> A closing note;- I am writing this in Auckland just prior to Jim and I boarding a flight to Chatham Islands to attend the opening and blessing tomorrow of the first Moriori marae, Te Kopinga. Aroha mai for not giving a detailed overview of the events since the last Kukupa up to the end of the year 2004. Te Rangi Aniwaniwa Academic Achievements

Two boys broke the mana wahine record of academic achievement at Te Rangi Aniwaniwa this year: Dylan Smith in the juniors and Tumoana Halkyard in the year 3 class.

Six seniors will move on to tertiary studies next year: Janelle Popata (wharekura dux) to AUT, Nikkita Vaeagi to Mainz Music School, Heeni Brown to Auckland University Sciences; Ngahuia Harawira to Auckland University Law School, Christian Seumanu to Maori and Pacific Development at Waikato University and Hune Rapihana to AUT.

A Diploma in Maori Performing Arts was offered to students this year via Pounamu Performing Trust which is a culmination of four years study. Both the junior and senior kapa haka represented Tai Tokerau at the national competitions held in Wellington and Rotorua. Special thanks to the tutors: Missy Edwards, Henare King, Malcolm Kereoma, Chris and Sandra Henare who gave much of their time throughout the year.

The wharekura boys were privileged to be part of the Muruwhenua waka taua project alongside Nicky Tauhara and Hekenuku mai Busby of Te Aurere.

There was a 100% pass rate of the 8 wharekura students who sat the Diploma of Matauranga Maori via Te Wananga o Raukawa, and a 100% pass rate in the senior students who sat te reo papers at Waikato University.

The Board wish to thank the waka ama coaches Bo Herbert, Dave King and Hilda Harawira who prepared the eight students for worlds representation at Hilo, Hawaii this year. Wiremua and Anaru Ratana (Taupeke Surfers under 16s) returned with a bronze medal in the 500m sprints; and all six girls Harata Brown, Waimarie Halkyard (Chyrstal Lightsunder

16s); Rangi Moses, Ngahuia Harawira, Heeni Brown and Leonie Murray (Ngatu Lakers under 19s) were three-time finalists in the 500m, 1000m and w12 sprints. All students have been registered to compete at the World Sprints in Karapiro 2006.

Thanks to the basketball coaches, managers and officials who gave their time for coaching and transporting teams: Manuera Riwai (head Coach), Richard and Edna Murray, Hilda Harawira, Otere Mare, Norma Moses, Tanya Halkyard and Lisa Ratana. For a school with an old Lance Baker hoop and no court, the kura did extremely well. 4 boys participated in the NZ Area schools bball team, 9 girls attended the national secondary basketball championships in Auckland, and five students made national teams: Rangi Moses (NZ Under 18s); Harata Brown, Waimarie Halkyard and Philippa Murray (NZ Koru under 16 girls) and Whiria Meltzer in the NZ Koru under 16 boys.

Thanks also to Huria Kira, junior netball coach and Tiwai Steedman the squash coach. Snapps organiser Lewis Norman is to be congratulated for encouraging many seniors to join the open touch competition.

Kia ora also to Bruce Kinsey from Broadwood Area School, who picks up several of our rugby players for school tournaments, as our kura is too small to field a rugby side.

Hilda Halkyard-Harawira relieving tumuaki for term 4, has returned to the Wananga. Acting Principal is Ngaire Tauhara White. The principal position is advertised to start term 2, 2005.

All wharekura students and their whanau are expected to reenrol on Thursday 27 January 2004. Whanau will be asked to sign agreements for commitment to te reo Maori, the special kaupapa of the kura, self regulated behaviour, correct uniform, regular homework and good attitude to peers and staff.

Kotahi Tatou Waka Ama Team compete at the Nationals

Monday the 17th of January saw the Kotahi Tatou girls waka ama team travel to Hamilton for the annual waka ama nationals.

The girls, accompanied by a strong contingent of family and supporters, arrived at the Flying Hedgehog hotel late Monday afternoon. Day one of the competition brought beautiful weather as the girls and their support crew travelled to Lake Karapiro. Senior coach Manuera Riwai with his trusty support crew strategically planned the girls'

first race as they waited patiently under the covers of the Te Oranga marquee.

1000's of paddlers and supporters packed the edge of the ripple less lake. With experienced teams from all over the country competing, every bit of assistance was sorted as the girl's race number was called across the loud speaker. Some final words from Hilda Harawira gave the girls a bit more confidence as they departed from the rest of the crew to the loading bay. The first race was the 500-metre sprint, which required a top 3 finish in their heat in order to qualify for the next round. As the race started supporters of the girls cramped the edge of the bank, as they passed the 250 mark the home girls were in the lead, this excited the supporters as they ran aimlessly along the lake banks shouting words of encouragement.

As the race came to an end the girls were unable to maintain their quick pace and finished 7th, a result that was a little disappointing considering their great start. An early finish to the day saw the girls travel to the Te Rapa pools

where they spent the afternoon relaxing for the next day's 1000 metre race. Day 2 brought another beautiful day and another early morning start. A brisk breeze swept across the lake, which made for a choppy surface. Today saw more urgency in the camp as the girls got a pre-race talk from Lewis Norman and Hilda. As they made their way to the loading bay a more focused crew loaded the waka.

The race started and the girls seemed to be out of sorts, as they approached the first turn they were seventh but as they came out of the turn they had jumped 5 places to second. The supporters couldn't believe how tight their turn was, the efforts from the girls to achieve a near flawless turn was well beyond their experience.





The girls had only been paddling one month prior to the nationals and there they were showing up teams that had been paddling for years. As they approached their second turn however the girls had slipped back but again out of the turn and they were back in contention.

As the home straight neared the girls were fighting to stay in 3rd position but as they crossed the finish line they had just slipped back to 4th, a result that would see them qualify for a semi-final spot later in the day. The result of the semis was irrelevant as the girls had achieved more than what was expected. With 12 months experience under their belt for next year's nationals we can guarantee these girls will be back and contending for next year's U16 title. The team of Kirsty Maheno, Adonia Lewis, Brogan Riwai, Jessie Hadfield, Tamara Matiu and Freda Riwai along with coach Manuera Riwai should be very proud of their achievements.

Ensuring the Sustainability of Customary Toheroa Harvest

Plentiful harvests of large-sized toheroa from numerous locations along Te One Roa-a-Tohe, and other more secret locations, is a fond memory of many iwi members. However, more recently the experience of many customary toheroa harvesters has been one of having to harvest smaller animals, not knowing where to find them or just concern that maybe the present customary harvest system is unsustainable. Recently, there has been renewed interest about the customary harvest of toheroa, stemming from reports that the populations on Te One Roa-a-Tohe were becoming increasingly impacted by customary harvesters and poachers. In response to these reports a rahui has been introduced to allow the toheroa time to recover. To tackle the problem from a scientific perspective, a research proposal is currently being developed by the Cawthron Institute and Northland iwi, including Te Rarawa. If funded, the research will study some of the human impacts on toheroa as well as natural processes.

The project will use several strategies to increase the customary harvest of toheroa. Firstly, the research will look at the influence of humans (e.g. harvesting, poaching, vehicle damage and land use changes) and natural factors (e.g. bird predation and water movement). Secondly, using Matauranga Maori relating to the toheroa and scientific data collected, recommendations to guide and better manage activities impacting toheroa will be drafted. It is envisaged that one or more management plans will be developed by iwi parties in parallel to the research. Thirdly, directly enhancing toheroa beds with spat, produced in an aquaculture hatchery, to ensure there are enough toheroa for harvest three or four years later. This is an option similar to the current practice of translocation carried out by Kaitiaki groups, but aims to add young toheroa once they have passed their most vulnerable stage.

The primary benefit of the project will be more effective management of the toheroa resource by Maori, ensuring sustainability and empowering Maori to exercise greater control over a valued resource.

What is the Cawthron Institute?

A private, independent, not-for-profit research centre, which has been operating in Nelson for 84 years. Specialist fields include: aquaculture of shellfish, bio-security issues, marine and freshwater science, and analytical chemistry and microbiology. Shade Smith (Te Uri o Hina, Ngati Pakahi) is a scientist working for Cawthron who will be heading the toheroa project.



Computer Tip

This Issue's Computer Tip: Anti-Virus Software

It's a fact of computer that there are people in the world who do very little except write computer programs that cause problems to millions of people. Just for fun, keep in mind.

Luckily you can protect yourself against these viruses. If you have some up-to-date antivirus software installed on your computer you should be fine. The problem arises when one of two things happen: 1: You don't update your antivirus software, or

2: Your paid subscription to the antivirus software company runs out, and you can't update your antivirus software anymore.

How much will antivirus software cost?

Many people are under the impression that you have to buy antivirus software. It's true that you can pay \$50-\$200 for some, but there are many free ones available - that's free to install and free to update, and as good as (if not better than) some bought ones.

The free one that Te Runanga O Te Rarawa recommends is called AVG 7. You can download it from www.grisoft.com

Make sure you get the free version and not the 30-day trial version.

Once downloaded (which may take 30 minutes or so), install the software and it will protect you. If you are running some other antivirus software such as Norton Antivirus or PCillian, remember to remove it first (via add/remove programs in the Control Panel).

Why do I need to update my antivirus software?

This is a common question. People feel if they have the software then they will be protected forever. Not so. You need to update the antivirus software's list of known viruses so if a new one comes out, it knows what to look for and can detect (and remove) it. If it doesn't know about the new virus, it cannot stop it and your PC will get infected. Think of the antivirus software as a doorman outside your house. He has a list with known terrorists on it. If the terrorist comes to your door and he's on your doorman's list, he won't let him in. If

he's not on the list he goes in. That's why you need to update your list, say at least once a week, although the AVG software will do this automatically when you go on the internet.

Horticulture Courses Grow through Te Runanga O Te Rarawa

Te Runanga O Te Rarawa's partnership with Northland Polytechnic in providing training in Horticulture is proving

to be very popular option and continues to expand into more areas in the Far North.

Rongo Bentson, the Manager for the courses, says that demand for courses in more areas has led to the need to employ two tutors and expansion to Peria, Mangamuka and Pawarenga.

"People old and young, men and women are keen on getting back into growing their own vegetables and everybody wants to grow them organically, getting away from the sprays and chemicals." Rongo (who is also the Chairman of TOPIS, Tai Tokerau Organic Producers Inc. Soc) believes it is a sign that people are becoming more aware of the need to take responsibility for their own health and wellbeing as well as getting back into the land. Rongo says that the enthusiasm in these communities is really overwhelming; "the course is giving the communities an opportunity for generating some positive activity that involves the two greatest resources that we have; people and land. Students are learning gardening skills and good land use management, getting the

qualifications; but the interesting thing is that the knowledge is not only coming from the books but it has also given the kaumatua and kuia an opportunity to pass their knowledge on to some keen students. As a result, on every course we have people enrolled varying in age from 15 to 70."

The Tutors too are very passionate about gardens and land use management. Alistair Newman has, apart from tutoring for many years, his own farm that is totally organic and based on the permaculture principle. John Hill finds his knowledge and experience from setting up and operating the Lemonwood Nursery in Awanui handy now to build up nurseries both in Kaitaia and Pawarenga.



The courses (which are free and full-time) consist of two days theoretical learning of units and two days practical on community-based projects which is gardens, native tree nurseries and eventually land restoration projects. Fridays are left for students to catch up on some studies at home.

The courses will be continuing for virtually the whole of 2005 and upon completion will give students a National Certificate Level 2, which will most certainly increase their employment opportunities within the Horticulture industry. Graduates will also have the option to go on to a Level 4 Horticulture Course which is more business orientated.

Rongo concludes that it is his firm belief that if we want to see any economic development in the Far North that is going to benefit the majority of the people and include our rural communities, we need to make the land productive.

"If we look after the land the land will look after us hence the need for some good land use practices."

Work Programme - The Year Ahead

One of the outcomes of last year's Roadshow hui was a repeated call for the Negotiations Team to get a broad package together before bringing it back to the Runanga for consideration. There was feeling that the major issues needed to be considered together. Having now had two key Minister's meetings (see below), we are now focused on getting the key components of a package together over the coming months. The Team has reduced its negotiations meetings with the Crown to one meeting per month so we can devote more time to internal iwi consultation and developing the DoC estate redress. Negotiations Team activities since our November/ December 2004 Kukupa report included:

- Runanga meeting, Motuti, 20th October 2004
- Meeting with Tauroa whanau, Kaitaia, 26th October
- Negotiations with the Crown, Kaitaia, 28th October
- Road show hui with Taurahere in Auckland, 3rd November
- Meeting with the Crown Forest Rental Trust (CFRT), Kaitaia, 12th November
- Meeting with Owhata whanau, Owhata, 13th November
- National Library Tour (relationship building to facilitate iwi research), 15th November
- Negotiation planning meeting with Lawyer, Wellington, 15th November
- Meeting with Minister of Treaty Settlements, Margaret Wilson, Wellington, 15th November
- Shared interest hui with Te Aupouri, Kaitaia, 8th December.

- Negotiations briefings and meeting with legal counsel, Auckland, 9th December
- Liaison with legal Counsel Wellington, 15th /16th December
- Meeting with Minister of Conservation, the Minister of Treaty Settlements and Office of Treaty Settlements officials, Wellington, 16th December
- Negotiations with the Crown, Wellington, 16th December
- Negotiators meeting with Department of Conservation (DoC), Far North District Council (FNDC) and Tauroa whanau on Tauroa Housing matters, Kaitaia, 20th December
- Negotiations Team Planning day with the Runanga Executive, Kaitaia, 17th January 2005
- Negotiations with the Crown, Auckland, 19th January

Minister's Meetings in 2004 – Quantum & Whenua Ngahere

Minister of Treaty Settlements Margaret Wilson, 15th November

The Negotiations team met with to discuss Quantum and a way forward for our Whenua Ngahere proposal.

We argued that our quantum should be substantially more than the \$12M Crown offer accepted in principle by Te Aupouri because:

- Our iwi numbers are much larger
- Our land loss was twice as much
- Our structure with 30 hapu is much more complex than Te Aupouri, which is based around one marae.

The Minister took on board what we were saying and said that she would get back to us in due course with a response.

Secondly, we had considerable discussion on our Whenua Ngahere proposal for shared custodianship of DoC lands. The Minister accepted the rationale for what we are trying to achieve but felt that the case is difficult to argue politically. She agreed to support more work being done on the proposals and to sponsor a meeting with the Minister of Conservation, Chris Carter, whose support would be required in order for the proposal to succeed.

Minister of Conservation Chris Carter, & Margaret Wilson, 16th December

The Negotiations team met with both Ministers on whenua ngahere as a follow up to the 15th November meeting with Minister Wilson. Minister Carter agreed that the proposal presented some political challenges, but was interested enough to support developing it further with Crown officials. The Negotiations Team was pleased to finally have obtained the necessary high level Ministerial buy-in for this work. We now have a fairly tight timeframe within which to complete the proposal to a stage where it may be considered by Cabinet.

Foreshore and Seabed

The Negotiations Team has received some helpful advice about how Te Rarawa might best mitigate the effects of the Foreshore and Seabed Act. The path of negotiating some redress in our current claims negotiations seems to hold a number of advantages rather than going to the High Court under the Act. We will be seeking iwi

guidance on which approach to take on 10th February.

Tauroa

The Negotiations team met with Tauroa representatives to unify our thoughts before setting up further meetings with DoC and the FNDC on 20th December. At that meeting, there was some positive discussion on all sides about a process of exploring the establishment of a permanent Nohoanga at Tauroa for Te Rarawa.

Aupouri shared interests

Now that Te Aupouri has reached a settlement Agreement in Principle with the Crown they have moved on to redress issues. The Negotiations Team and a number of key Te Rarawa kaumatua met with Te Aupouri negotiators on 8th December 2004 to discuss redress and shared iwi interests. Te Rarawa will continue with discussions with Te Aupouri in 2005.

Historical Redress

The Research Team has identified some 'gaps' in the Historical Overview (Working Draft) Report of claimant grievances, and will continuing to refine the Report in the coming months. From this material the Team will produce a Claims Report from our iwi perspective that will be used to develop the Historical Account, Crown Acknowledgements and Apology in the settlement. Whanau are urged to read the draft Report and feed us their comments about how well their grievances are covered (or not). For copies, contact your marae or Catherine Davis at the Runanga. The Report may also be viewed from our iwi website.

Investment and Distribution Strategy

The Team and the Executive have distributed to Runanga Delegates a discussion paper about iwi policy on the investment and distribution of any assets Te Rarawa may receive from the Fisheries and Treaty claims settlements. A copy of the paper is also available on our iwi website or on request from our office. The Team seeks iwi input into the important issues raised in the paper. With this input we hope to approve some key policy decisions by mid 2005.

CFRT Claimant Funding

At the end of 2004 the Negotiations Team signed a funding contract with CFRT for \$230K to assist with the Negotiations work. The resources will be a big help and take some pressure off the Runanga resources that have been used to underwrite the process.

TE RARAWA HOUSING

2004 was another huge year for Te Rarawa and 2005 will be no different. We want to thank our Commercial Manager, Vance Winiata, and Kevin Pilbrow, our carpentry tutor, who left our midst at the end of year. We will sadly miss these two wakaama icons that paddled through 2003 and 2004 with the carpentry course and delivered meritorious outcomes and relationships.

This year we will continue with the Carpentry Course, but it may not be from the Northland Polytechnic property. There are a number of other courses that have sprung up and the site (that was sitting obscured in 2002) has now a new lease of life, and one could only assume that Te Rarawa Carpentry course had started it all.

We are in process of identifying sites that we can deliver the course from. The Northland Polytechnic site had an impact on the community because of its high profile nature. It will be hard to find another site that will deliver the same impact.

This year we will look at opportunities to be more creative and innovative. The housing team has grown over the past two years from two employees to nine. Three other employees are now employed with a local building company.

There have been a number of highlights in 2004, including the noticeable reduction of 20 projects in comparison to 50 projects that were completed in 2003. 2 houses were completed on the course and 3 HNZC rentals in Awanui. The housing Team now has a sign that we will install on all our projects within Te Rarawa that will enable the community to identify which projects are in progress or have been completed.

This year we will be commencing a 7-kaumatua housing development within Kaitaia. 4 HNZC Rentals will be completed prior to June 2005, with another 6 more rentals, 20 more essential repair projects, 3 new/resited homes completed before the year end. We will be seeking financial approval from HNZC for housing developments in Motukaraka, Motuti, Pamapuria, Mangamuka and Panguru consisting of 2-4 houses in each. *Turi Te Hira*
